8 AN ORDINANCE to amend Section 2.32 relating to: Land Information Advisory Committee.

10 *The people of the County of Washington, represented in the Board of Supervisors, do*
11 *ordain as follows:*

13 **SECTION 1.** Section 2.32(1) and (2) of the code are amended to read:

14 **2.32(AM08-1) LAND INFORMATION ADVISORY COMMITTEE**
15 **COMMISSION.** (1)(AM 08-1) The Land Information Advisory ~~Committee~~ Commission shall
16 be appointed by the ~~County Board~~ Planning, Conservation and Parks Committee Chairperson.
17 The membership ~~of the Committee~~ shall include the Register of Deeds, Real Property Lister,
18 County Conservationist, GIS Manager/Land Information Officer, Highway Commissioner, She-
19 riff or designee, County Engineer/Surveyor, Assistant Administrator for Planning – Planning and
20 Parks Department, 1 ~~County Board Supervisor~~ Planning, Conservation and Parks Committee
21 member and 2 additional members consisting of citizens with a demonstrated interest in land in-
22 formation issues. See §59.72, Wis. Stats.

23
24 (2)(AM 08-1) Subject to the authority of the ~~County Board and the~~ Planning, Conserva-
25 tion and Parks Committee as its ~~Liaison Committee~~, the ~~Committee~~ Commission shall provide
26 direction and policy to the County’s Land Information Office, coordinate land information
27 projects within the County, promote the benefits and uses of the land information program, ap-
28 prove revisions to the Countywide plan for land records modernization and integration, previous-
29 ly adopted, and provide input on the Land Information Office’s recommendations regarding local
30 governmental unit project grant applications to the state Land Information Board.

31
32 **SECTION 2. EFFECTIVE DATE.** This ordinance shall become effective upon pas-
33 sage by the Board of Supervisors and publication as provided by law.

34
35 **SECTION 3. SUMMARY.** This ordinance amendment revises the composition and
36 appointment process for the Land Information Advisory Committee.
