2008 ORDINANCE 3

AN ORDINANCE to amend Section 7.03 of the code; relating to: Classification and Compensation Plan – Elected Department Heads.

The people of the County of Washington, represented in the Board of Supervisors, do ordain as follows:

SECTION 1. 7.03(4) of the code is amended to read:

7.03 WASHINGTON COUNTY CLASSIFICATION AND COMPENSATION PLAN. (4)(AM 08-3) **Elected Department Heads.** Pursuant to §§59.13 and 59.22, Wis. Stats., the County Board shall establish the salaries of elected department heads prior to the first day of June in even numbered years. Elected department head's salaries shall remain in effect unless duly changed by the County Board.
