AN ORDINANCE to amend Sections 7.02 and 7.03 relating to: Staffing Plan – County Board of Supervisors and County Clerk; and Classification and Compensation Plan.

The people of the County of Washington, represented in the Board of Supervisors, do ordain as follows:

SECTION 1. Section 7.02 of the code is amended to read:
7.02 WASHINGTON COUNTY DEPARTMENTAL STAFFING PLAN.

(22)(CR 08-7) This position shall be funded as follows: 1/3 County Board of Supervisors and 2/3 County Clerk.

SECTION 2. The list of pay grades established in Section 7.03(1)(a) shall be adjusted to incorporate the changes proposed in this ordinance.

SECTION 3. EFFECTIVE DATE. This ordinance shall become effective upon passage by the Board of Supervisors and publication as provided by law.

SECTION 4. SUMMARY. This ordinance amendment modifies the staffing plan to move a position from Office of County Board to the County Clerk.
