9 **Revised Relocation Order – County Trunk Highway Y**

10  
11 **WHEREAS**, Subsection 32.05(1), Wis. Stats., authorizes a County Board to issue a relo-  
12 cation order permitting the improvement of public highways and other transportation facilities;  
13 and

14  
15 **WHEREAS**, the Washington County Transportation Committee has reviewed the Coun-  
16 ty Trunk Highway Y project as presented by the Highway Commissioner and recommends adop-  
17 tion of a revised relocation order to permit modification to County Trunk Highway Y as autho-  
18 rized by §83.08, Wis. Stats., to the extent necessary to make substantial improvements to the  
19 highway including installation of stormwater management devices as required, pavement widen-  
20 ing, shoulder widening, associated grading; and improved vertical alignment;

22 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of Su-  
23 pervisors that this Resolution shall constitute a revised relocation order in accordance with  
24 §32.05(1), Wis. Stats., for the purpose of the within desired highway improvement project, and  
25 shall further constitute a determination of necessity for that project in accordance with §32.07(2),  
26 Wis. Stats.;

27  
28 **BE IT FURTHER RESOLVED** that the Board hereby determines that it is necessary  
29 and for a public purpose to modify County Trunk Highway Y so that it may be improved and  
30 that said modification will be built within the areas marked “Begin Relocation Order – End Re-  
31 location Order”, as set forth in the scale drawing of the proposed modification plan, which is at-  
32 tached to this resolution as Exhibit "A";

33  
34 **BE IT FURTHER RESOLVED** that the lands and interests to be affected by this high-  
35 way project are specifically depicted and described in Exhibit "B" attached hereto and incorpo-  
36 rated herein by reference;

37  
38 **BE IT FURTHER RESOLVED** that both fee simple interests and easement interests, as  
39 appropriate, shall be acquired in the areas described in Exhibits "A" and "B".

41 **BE IT FURTHER RESOLVED** that a copy of this revised relocation order along with  
42 all supporting documentation shall, within twenty days after its passage, be filed with the County  
43 Clerk;
