8 **2009 Budget Appropriation**

10 **WHEREAS**, the proposed 2009 Budget Summary – Washington County was published  
11 in the West Bend News on October 17, 2008, in accordance with the provisions of Wisconsin  
12 Statutes Section 65.90; and

13  
14 **WHEREAS**, estimated expenditures and revenues for 2009 are shown on the  
15 Washington County 2009 Budget available for review at Washington County and incorporated  
16 herein by reference; and

17  
18 **WHEREAS**, the total indebtedness of Washington County as of December 31, 2008, is  
19 thirty-three million seven hundred fifty thousand (\$33,750,000) dollars;

20  
21 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of  
22 Supervisors that the 2009 budget appropriations, in the sums and for the purposes hereinafter set  
23 forth, be and the same are hereby adopted;

25 **BE IT FURTHER RESOLVED** that by the adoption of this resolution, the Washington  
26 County Board of Supervisors levies a tax against the taxable property of Washington County,  
27 both real and personal, sufficient to provide for the 2009 budget appropriations in Washington  
28 County 2009 Budget, it being understood that this general levy shall not duplicate other levies  
29 adopted by this Board;

31 **BE IT FURTHER RESOLVED** that the County Clerk be and is hereby authorized and  
32 instructed to assess said levy to the municipalities of Washington County in accordance with the  
33 schedule of equalized values as prepared by the Wisconsin Department of Revenue and presented  
34 to this Board;

36 **BE IT FURTHER RESOLVED** that a copy of this Resolution, including the  
37 Washington County 2009 Budget, and any amended version be made available for public  
38 inspection in the Office of the Washington County Clerk, upon its adoption, as provided by law.

15 (The 2009 Proposed Budget includes total operating expenses of \$125,691,755 and total operating  
16 revenues of \$87,348,605. The expenses include \$1,599,761 for Library Services and \$150,000 for  
17 County Bridge Aid. Based on the County's total valuation of \$13,501,958,850, the recommended  
18 County tax rate is \$2.7102 per \$1,000 of equalized valuation. The Library adds \$0.2283 per  
19 \$1,000 of equalized valuation in the municipalities affected by the library. County Bridge Aid  
20 adds \$0.0308 per \$1,000 of equalized valuation to the towns.)
