8 AN ORDINANCE to amend Sections 7.02 and 7.03 of the code; relating to: Staffing Plan and  
9 Classification and Compensation Plan – Planning and Parks Department.

12 *ordain as follows:*

14 **SECTION 1.** Section 7.02 of the code is amended to read:

15 **7.02 WASHINGTON COUNTY DEPARTMENTAL STAFFING PLAN.**

22 (9) Authorized only while appropriate non-County funds meet the full cost of these positions.

24 (10) The level of funding of the cost of salary and benefits through the use of County funds is  
25 determined on an annual basis in agreement with the Board of Supervisors.

27 (16)(AM 09-16) (Reserved) ~~One Technician position will be filled by transfer of a Land Use In-~~  
28 ~~spector, and will continue to be paid at the E 3 pay grade, pursuant to County Board ac-~~  
29 ~~tion April 20, 2004. At such time that this individual leaves the position, the position and~~  
30 ~~pay reverts to the E 2 pay grade.~~

34 **SECTION 2.** The list of pay grades established in Section 7.03(1)(a) shall be adjusted to  
35 incorporate the changes proposed in this ordinance.

37 **SECTION 3. EFFECTIVE DATE.** This ordinance shall become effective upon  
38 passage by the Board of Supervisors and publication as provided by law.

40 **SECTION 4. SUMMARY.** Ordinance amendment to allow for vacant position in Plan-  
41 ning and Parks Department to be filled only while appropriate non-County funds meet full cost of  
42 position.
