### 2009 ORDINANCE 24

AN ORDINANCE to amend Sections 7.02 and 7.03 of the code; relating to: Staffing Plan and Classification and Compensation Plan – Health Department.

*The people of the County of Washington, represented in the Board of Supervisors, do ordain as follows:*

**SECTION 1.** Section 7.02 of the code is amended to read:
