8 **Grant Application – Digital Recording Equipment**

10 **WHEREAS**, Washington County Code Section 4.27 requires that certain county grant
11 programs or applications for funds receive prior approval by the County Board of Supervisors;
12 and

13
14 **WHEREAS**, pursuant to 2005 Act 60, Wisconsin law requires recording of certain ju-
15 venile custodial interrogations and all felony interrogations; and

16
17 **WHEREAS**, the Washington County Sheriff's Department was awarded an initial grant
18 for the purchase of digital recording equipment for use in juvenile custodial interrogations and
19 felony interrogations in the amount of \$8,400; and

20
21 **WHEREAS**, the Washington County Sheriff's Department has awarded a second grant
22 for the purchase of digital recording equipment for use in juvenile custodial interrogations and
23 felony interrogations in the amount of \$6,087; and

24
25 **WHEREAS**, additional interview rooms in the Sheriff's Department would benefit
26 from the installation of recording equipment; and

27
28 **WHEREAS**, the Sheriff's Department has been awarded a third grant for a total of
29 \$11,592, with no match funding required;

31 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of
32 Supervisors that this Board approves and authorizes the Sheriff's Department to apply for and
33 accept the Wisconsin Department of Administration, Office of Justice Assistance, grant funds
34 for digital recording equipment, with the understanding that there be no additional staffing and
35 no additional direct costs incurred by Washington County.

37 **BE IT FURTHER RESOLVED** that the Sheriff is authorized to execute the necessary
38 application or other documents in order to obtain grant funding described herein, subject to re-
39 view and approval of the County Attorney's Office.
