11 **WHEREAS**, the proposed 2010 Budget Summary – Washington County was published
12 in the West Bend News on October 17, 2009, in accordance with the provisions of Wisconsin
13 Statutes Section 65.90; and

14
15 **WHEREAS**, estimated expenditures and revenues for 2010 are shown on the
16 Washington County 2010 Budget available for review at Washington County and incorporated
17 herein by reference; and

19 **WHEREAS**, the total indebtedness of Washington County as of December 31, 2009, is
20 thirty-one million nine hundred eighty-five thousand (\$31,985,000) dollars;

22 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of
23 Supervisors that the 2010 budget appropriations, in the sums and for the purposes hereinafter set
24 forth, be and the same are hereby adopted;

26 **BE IT FURTHER RESOLVED** that by the adoption of this resolution, the Washington
27 County Board of Supervisors levies a tax against the taxable property of Washington County,
28 both real and personal, sufficient to provide for the 2010 budget appropriations in Washington
29 County 2010 Budget, it being understood that this general levy shall not duplicate other levies
30 adopted by this Board;

32 **BE IT FURTHER RESOLVED** that the County Clerk be and is hereby authorized and
33 instructed to assess said levy to the municipalities of Washington County in accordance with the
34 schedule of equalized values as prepared by the Wisconsin Department of Revenue and presented
35 to this Board;

37 **BE IT FURTHER RESOLVED** that a copy of this Resolution, including the
38 Washington County 2010 Budget, and any amended version be made available for public
39 inspection in the Office of the Washington County Clerk, upon its adoption, as provided by law.

16 revenues of \$76,439,003. Based on the County's total valuation of \$13,489,971,850, the
17 recommended County tax rate is \$2.7717 per \$1,000 of equalized valuation. The Library adds
18 \$0.2330 per \$1,000 of equalized valuation in the municipalities who do not have library service.)
