8 **Establishing Public Participation Procedures**  
9 **For Amendments to the Multi-Jurisdictional Comprehensive**  
10 **Plan for Washington County: 2035.**

12 **WHEREAS**, §66.1001(4)(a), Wis. Stats., requires that amendments to a comprehensive  
13 plan be carried out in accordance with an adopted public participation plan designed to foster  
14 public participation in the amendment process; and

16 **WHEREAS**, the Washington County Board of Supervisors in 2007 Resolution 86 and  
17 2007 Ordinance 37 adopted the comprehensive plan embodied in SEWRPC Community Assis-  
18 tance Planning Report No. 287, A Multi-Jurisdictional Comprehensive Plan for Washington  
19 County: 2035; and

21 **WHEREAS**, the Washington County Board of Supervisors in 2004 Resolution 45 re-  
22 solved to adopt the Public Participation Plan for development of the Multi-Jurisdictional Com-  
23 prehensive Plan for Washington County: 2035 which has been used as a guide for the develop-  
24 ment of a Public Participation Plan for Amendments to the Multi-Jurisdictional Comprehensive  
25 Plan for Washington County: 2035;

27 **WHEREAS**, the Washington County Board of Supervisors encourages regular, meaning-  
28 ful public involvement in the comprehensive plan process and plan amendments are important to  
29 assure that the resulting plans are based on public input; and

31 **WHEREAS**, the Public Participation Plan for amendments to the Multi-Jurisdictional  
32 Comprehensive Plan for Washington County: 2035 includes written procedures to foster public  
33 participation, ensure wide distribution of draft plan materials, provide opportunities for written  
34 comments on such materials, and provide mechanisms to respond to such comments;

36 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of Su-  
37 pervisors that the board hereby adopts the written procedures set forth in the Public Participation  
38 Plan, dated December 2009, as its public participation plan for amendments to the Multi-  
39 Jurisdictional Comprehensive Plan for Washington County: 2035 meeting the requirements of  
40 §66.1001(4)(a), Wis. Stats., which plan is attached hereto as Exhibit "A".
