8 **County Aided Bridge Repair - Town of Farmington**

10 **WHEREAS**, Washington County has a county aid bridge and culvert program under
11 Section 12.06 of the Washington County Code of Ordinances; and

12
13 **WHEREAS**, the Town of Farmington had petitioned by resolution the Washington
14 County Transportation Committee requesting aid for the replacement of an existing bridge on
15 Jay Road, approximately 0.05 miles east of Orchard Valley Road in the Town of Farmington;
16 and.

18 **WHEREAS**, the aforementioned bridge was in poor condition and in need of replace-
19 ment; and

20
21 **WHEREAS**, the existing bridge met the standards and specifications for design and con-
22 struction set by Wisconsin Department of Transportation; and

23
24 **WHEREAS**, the Washington County Transportation Committee has reviewed the resolu-
25 tion of the Town of Farmington requesting aid and the proposed bridge replacement and recom-
26 mends approval of same; and

28 **WHEREAS**, the town and county expected to equally share (\$125,000 each) in the cost
29 of this replacement with an estimated total repair cost of \$250,000; and

30
31 **WHEREAS**, the county's share of this bridge replacement had been allocated in the 2009
32 Annual Budget;

33
34 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of Su-
35 pervisors that said petition is hereby granted and that provision for the county costs associated
36 with this project was included in the 2009 county budget of the Highway Department;

38 **BE IT FURTHER RESOLVED** that upon the filing of written notice with the County
39 Clerk by the Town of Farmington and the County Transportation Committee that the work was
40 completed and accepted by the Town Board and the County Transportation Committee, the
41 county's share of the project costs was disbursed to the town.
