8 **County Aided Bridge Repair - Town of Hartford**

9  
10 **WHEREAS**, Washington County has a county aid bridge and culvert program under  
11 Section 12.06 of the Washington County Code of Ordinances; and

12  
13 **WHEREAS**, the Town of Hartford has petitioned the Washington County Board of  
14 Supervisors requesting aid for the replacement of an existing culvert on Turtle Road  
15 approximately 0.26 miles west of County Trunk Highway K in the Town of Hartford; and

16  
17 **WHEREAS**, the aforementioned culvert is in poor condition and in need of replacement;  
18 and

20 **WHEREAS**, the existing culvert meets the standards and specifications for design and  
21 construction set by the Wisconsin Department of Transportation; and

22  
23 **WHEREAS**, the Washington County Transportation Committee, at its meeting on June  
24 15, 2010, reviewed the Town of Hartford's petition requesting aid for the proposed culvert  
25 replacement and recommended approval; and

27 **WHEREAS**, the Town and County expect to equally share in the cost of this  
28 replacement with an estimated total repair cost of \$11,000.00; and

29  
30 **WHEREAS**, the County's share of this culvert replacement will be included in the  
31 proposed 2011 Annual Budget;

33 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of  
34 Supervisors that said petition is hereby granted and that provision for the County costs associated  
35 with this project shall be made a part of the 2011 County budget of the Highway Department;

36  
37 **BE IT FURTHER RESOLVED** that upon the filing of written notice with the County  
38 Clerk by the Town of Hartford and the County Transportation Committee that the work has been  
39 completed and accepted by the Town Board and the County Transportation Committee, the  
40 County's share of the project costs shall be disbursed to the Town.
