8 **Relocation Order – County Trunk Highway D**

9  
10 **WHEREAS**, Subsection 32.05(1), Wis. Stats., authorizes a County Board to issue a  
11 relocation order permitting the improvement of public highways and other transportation facilities;  
12 and

13  
14 **WHEREAS**, the Washington County Transportation Committee has reviewed the County  
15 Trunk Highway D project as presented by the Highway Commissioner and recommends adoption of  
16 a relocation order to permit modification to County Trunk Highway D as authorized by §83.08,  
17 Wis. Stats., to the extent necessary to make substantial improvements to the highway including  
18 pavement widening, shoulder widening, associated grading, improved vertical alignment and  
19 replacement of bridge over Rock River;

20  
21 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of  
22 Supervisors that this Resolution shall constitute a relocation order in accordance with §32.05(1),  
23 Wis. Stats., for the purpose of the within desired highway improvement project, and shall further  
24 constitute a determination of necessity for that project in accordance with §32.07(2), Wis. Stats.;

26 **BE IT FURTHER RESOLVED** that the Board hereby determines that it is necessary and  
27 for a public purpose to modify County Trunk Highway D so that it may be improved and that said  
28 modification will be built within the areas marked “Begin Relocation Order – End Relocation  
29 Order”, as set forth in the scale drawing of the proposed modification plan, which is attached to this  
30 resolution as Exhibit "A";

31  
32 **BE IT FURTHER RESOLVED** that the lands and interests to be affected by this highway  
33 project are specifically depicted and described in Exhibit "B" attached hereto and incorporated  
34 herein by reference;

35  
36 **BE IT FURTHER RESOLVED** that both fee simple interests and easement interests, as  
37 appropriate, shall be acquired in the areas described in Exhibits "A" and "B".

39 **BE IT FURTHER RESOLVED** that a copy of this relocation order along with all  
40 supporting documentation shall, within twenty days after its passage, be filed with the County  
41 Clerk;
