2011 ORDINANCE 2

AN ORDINANCE to amend Sections 7.02 and 7.03 of the code; relating to: Washington County Departmental Staffing Plan – Health Department, Highway Department, Human Services – Access and Outreach, Human Services – Administration, and Samaritan Health Center – Nursing Services; and Classification and Compensation Plan.

The people of the County of Washington, represented in the Board of Supervisors, do ordain as follows:
