8 AN ORDINANCE to amend the Shoreland/Wetland/Floodplain Zoning Maps established and
9 maintained pursuant to Sections 23.02, 23.03 and 23.16 of the code; relating to:
10 Shoreland/Wetland/Floodplain Zoning Maps.

12 *The people of the County of Washington, represented in the Board of Supervisors, do ordain*
13 *as follows:*

15 **SECTION 1.** The Shoreland/Wetland/Floodplain Zoning Maps, Washington County,
16 Wisconsin, established and maintained pursuant to Sections 23.02, 23.03 and 23.16 of the
17 Washington County Code are amended to a Non-Shoreland Zoning District from a Shoreland
18 Zoning District, for the property located in NE quarter of the SE quarter, Section 25, Township
19 12 North, Range 18 East, Town of Wayne, more particularly described on the exhibit which is on
20 file with and can be inspected at the Washington County Planning and Parks Department and at
21 the County Board meeting.

23 **SECTION 2.** The Shoreland/Wetland/Floodplain Zoning Maps, Washington County,
24 Wisconsin, established and maintained pursuant to Sections 23.02, 23.03 and 23.16 of the
25 Washington County Code are amended to a Shoreland Zoning District from a Non-Shoreland
26 Zoning District, for the property located in the NE of Section 11 and the NW quarter, Section 12,
27 Township 10 North, Range 20 East, Town of Jackson, more particularly described on the exhibit
28 which is on file with and can be inspected at the Washington County Planning and Parks
29 Department and at the County Board meeting.

31 **SECTION 3.** The Shoreland/Wetland/Floodplain Zoning Maps, Washington County,
32 Wisconsin, established and maintained pursuant to Sections 23.02, 23.03 and 23.16 of the
33 Washington County Code are amended to a Non-Floodway Zoning District from a Floodway
34 Zoning District, for the property located in NE quarter, Section 9, Township 12 North, Range 20
35 East, Town of Farmington, more particularly described on the exhibit which is on file with and
36 can be inspected at the Washington County Planning and Parks Department and at the County
37 Board meeting.

39 **SECTION 4. EFFECTIVE DATE.** This ordinance shall become effective upon
40 passage by the Board of Supervisors and publication as provided by law.

42 **SECTION 5. SUMMARY.** This ordinance amendment authorizes a revision to
43 Shoreland/Wetland/Floodplain Zoning District maps for Section 25, Town of Wayne; Section 12,
44 Town of Jackson; and Section 9, Town of Farmington, Washington County.
