8 **Tentative County Supervisory District Plan**

10 **WHEREAS**, a county redistricting committee was assembled in March, 2011 to begin
11 the development of supervisory district plans (tentative and final) for Washington County and to
12 present plans to the County Board for approval pursuant to the process established at §59.10(3),
13 Wis. Stats.; and

14
15 **WHEREAS**, decennial federal census of population and maps showing the location and
16 numbering of census blocks became available in March of 2011; and

17
18 **WHEREAS**, the Redistricting Committee convened on several occasions and has
19 developed a tentative supervisory district plan which plan is consistent with, as much as
20 reasonably possible, the principles of redistricting and statutory requirements; and

22 **WHEREAS**, the Redistricting Committee solicited suggestions and comments from
23 municipalities and supervisors during the meetings concerning the development of the tentative
24 plan; and

25
26 **WHEREAS**, a public information meeting was held on May 16, 2011 during which the
27 public was invited to view the tentative plan, proposed district boundaries and the population
28 details relating to the plan; and

29
30 **WHEREAS**, the County Board conducted a public hearing on the tentative supervisory
31 district plan on May 16, 2011; and

32
33 **WHEREAS**, the County Board received testimony at the public hearing which will be
34 given consideration; and

36 **WHEREAS**, the tentative supervisory district plan is presented to the County Board as
37 Exhibit "A" attached to this resolution and incorporated herein; and

39 **WHEREAS**, the population details by district and the district deviation and plan
40 deviation details are attached hereto as Exhibit "B" and incorporated herein;

42 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of
43 Supervisors that the plan as shown on attached Exhibit "A" is hereby adopted by this Board as
44 the tentative supervisory district plan.

46 **BE IT FURTHER RESOLVED** that the County Clerk shall provide a written statement
47 to each municipality in the County specifying the approximate location of the territory from
48 which wards are to be created and the approximate population so that municipalities can adjust
49 its wards accordingly.
