8 AN ORDINANCE to repeal and recreate Section 2.01 relating to: Supervisory Districts.

10 *The people of the County of Washington, represented in the Board of Supervisors, do ordain*
11 *as follows:*

13 **SECTION 1.** Section 2.01 of the code is repealed and recreated to read:

14 **2.01 SUPERVISORY DISTRICTS.** (2)(AM 11-12) Each supervisory district shall
15 be represented by one supervisor to be elected from that district who shall serve for a 2-year term
16 commencing with the ~~2002~~ 2012 spring elections for County Board Supervisors.

18 (3)(RR 11-12) The supervisory districts of the County Board of Supervisors are
19 numbered and described as follows:

23 That portion of the City of West Bend consisting of Wards 1, 2 and 22.

28 That portion of the City of West Bend consisting of Wards 4, 5 and 12.

33 That portion of the City of West Bend consisting of Wards 6, 7 and 8 and that portion of
34 the Town of West Bend consisting of Ward 8.

39 That portion of the City of West Bend consisting of Wards 9, 10 and 11 and that portion
40 of the Town of West Bend consisting of Ward 10.

14 Town of Wayne consisting of Ward 1 and that portion of the Town of West Bend consisting of
15 Ward 7.

20 That portion of the Town of Kewaskum consisting of Ward 1 and that portion of the Vil-
21 lage of Kewaskum consisting of Wards 1, 2, 3, 4 and 5.

26 That portion of the Town of Farmington consisting of Wards 1, 2, 3 and 4 and that por-
27 tion of the Town of Kewaskum consisting of Ward 2.

32 The entire Town of Hartford consisting of Wards 1, 2, 3, 4 and 5 and that portion of the
33 City of Hartford consisting of Ward 14.

38 That portion of the Town of Barton consisting of Wards 1, 2 and 4 and that portion of the
39 Town of Wayne consisting of Wards 2 and 3.

44 That portion of the Town of Farmington consisting of Ward 5, that portion of the Village
45 of Newburg consisting of Wards 1 and 2, that portion of the City of West Bend consisting of
46 Ward 18 and that portion of the Town of Trenton consisting of Wards 1, 2, 3 and 4.

51 That portion of the Town of Jackson consisting of Wards 4, 5 and 6 and that portion of

24 That portion of the City of Hartford consisting of Wards 8, 9, 10, 11 and 17.

29 That portion of the City of Hartford consisting of Wards 1, 2, 3, 4, 6 and 7.

34 That portion of the City of Hartford consisting of Wards 5, 12 and 13.

39 The entire Town of Erin consisting of Wards 1, 2, 3 and 4 and that portion of the Village
40 of Richfield consisting of Ward 1.

45 That portion of the Village of Richfield consisting of Wards 2, 3 and 4.

50 That portion of the Village of Richfield consisting of Wards 5, 6 and 7.

3 That portion of the Village of Germantown consisting of Wards 3, 15 and 16 and that
4 portion of the Village of Richfield consisting of Wards 8 and 9.

7 **District 27**

9 The entire Town of Germantown consisting of Ward 1 and that portion of the Village of
10 Germantown consisting of Wards 1, 2, 4 and 5.
11
12

13 **District 28**

14
15 That portion of the Village of Germantown consisting of Wards 6, 7, 8 and 17.
16
17

18 **District 29**

19
20 That portion of the Village of Germantown consisting of Wards 10, 11 and 12 and that
21 portion of the City of Milwaukee consisting of Ward 318.

24 **District 30**

25
26 That portion of the Village of Germantown consisting of Wards 9, 13 and 14.
27

28 (4) The Executive Committee shall adjust the supervisory descriptions herein pursuant to
29 §59.10(3)(c), Wis. Stats., upon notification by the County Clerk of new municipal ward
30 information due to incorporation, annexation, detachment or consolidation.
31

32 **SECTION 2. EFFECTIVE DATE.** This ordinance shall become effective upon
33 passage by the Board of Supervisors and publication as provided by law.
34

35 **SECTION 3. SUMMARY.** An ordinance describing the County’s Final Supervisory
36 District Plan.
