8 AN ORDINANCE to recreate Section 4.41 of the Code relating to: Weapons Prohibited.

9
10 *The people of the County of Washington, represented in the Board of Supervisors, do ordain*
11 *as follows:*

13 **SECTION 1.** Section 4.41 is created to read:

14 **Section 4.41.** (CR 11-15) **WEAPONS PROHIBITED.** (1)(CR 11-15) It shall be
15 unlawful for any person to carry a weapon, including but not limited to a handgun or other
16 firearm, into or remain within any building owned or leased by the County or any of its
17 departments or agencies.

19 (2)(CR 11-15) Appropriate signage shall be prominently displayed at the entrances of
20 said buildings in the format and locations as required by §943.13(2)(bm), Wis. Stats., with the
21 same or substantially similar language as follows: ALL WEAPONS INCLUDING FIREARMS
22 PROHIBITED IN THIS BUILDING-WIS. STAT. §943.13(1m)(b) and (c).

24 (3)(CR 11-15) This ordinance shall not apply to law enforcement officers, enlisted
25 personnel of the armed forces, while in discharge of official duties, and those individuals
26 authorized in writing by an official granted the legal authority to give such written authorization.
27 This ordinance is intended to prohibit carrying weapons within County owned or leased
28 buildings consistent with the grant of authority pursuant to §943.13(1m)(b) and (c), Wis. Stats.,
29 and is not intended to supersede applicable state or federal laws.

30
31 **SECTION 2. EFFECTIVE DATE.** This ordinance shall become effective November
32 1, 2011 and upon passage by the Board of Supervisors and publication as provided by law.

33
34 **SECTION 3. SUMMARY.** Ordinance prohibiting weapons in buildings owned or
35 leased by the County.
