8 **Transfer from the General Fund – Unemployment Insurance – Special Assessment**

10 **WHEREAS**, the federal government advanced funds from the U.S. Treasury to several
11 states, including the State of Wisconsin, to fund the depleted Unemployment Insurance Reserves;
12 and

13
14 **WHEREAS**, the State of Wisconsin’s Unemployment Insurance Reserve Fund was
15 depleted in February of 2009; and

16
17 **WHEREAS**, in past years, the Federal Government has waived interest due from the
18 states on the loans made; and

19
20 **WHEREAS**, no waiver has been granted and the U.S. Treasury has issued an invoice to
21 the State of Wisconsin; and

22
23 **WHEREAS**, the State of Wisconsin, Department of Workforce Development, has
24 determined that it will assess employers for the interest charges based on a formula applied to the
25 employers’ payrolls as prescribed in Chapter 108 of the Wisconsin Statutes; and

27 **WHEREAS**, Washington County has been assessed \$16,819.81 in interest due the
28 Federal Government for the Wisconsin Unemployment Insurance Reserve Fund loan; and

30 **WHEREAS**, Washington County has received an invoice setting forth its assessment
31 requesting payment no later than September 9, 2011;

33 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of
34 Supervisors that an amount of \$16,819.81 is hereby transferred from the General Fund for the
35 purpose of paying interest due the Federal Government for the County’s portion of the
36 Wisconsin Unemployment Insurance Reserve Fund loan.
