8 AN ORDINANCE to amend Section 2.01 relating to: Supervisory Districts.

9
10 *The people of the County of Washington, represented in the Board of Supervisors, do ordain*
11 *as follows:*

13 **SECTION 1.** Section 59.10(3)(c), Wis. Stats., allows the Board to amend the
14 supervisory district plan from time to time after its enactment to reflect municipal incorporation,
15 annexation, detachment or consolidation.

17 **SECTION 2.** Section 2.01 of the code is repealed and recreated to read:

18 **2.01 SUPERVISORY DISTRICTS.** (3)(AM 12-10) The supervisory districts of the
19 County Board of Supervisors are numbered and described as follows:

22 **District 8**

24 That portion of the Town of West Bend consisting of Wards 1, 2, 3, 4, 5 and 6, and that
25 portion of the City of West Bend consisting of Ward 26.

26 * * *

28 **District 12**

30 The entire Town of Hartford consisting of Wards 1, 2, 3, 4 and 5 and that portion of the
31 City of Hartford consisting of Wards 14, 15, 16, 20, and 21.

32 * * *

34 **District 15**

36 That portion of the Town of Jackson consisting of Wards 4, 5 and 6, and that portion of
37 the Town of Trenton consisting of Wards 5, 6, 7 and 8, and that portion of the City of West Bend
38 consisting of Ward 25.

40 **SECTION 3. EFFECTIVE DATE.** This ordinance shall become effective upon
41 passage by the Board of Supervisors and publication as provided by law.

43 **SECTION 4. SUMMARY.** An ordinance adjusting supervisory district descriptions to
44 accommodate wards due to incorporation, annexation, detachment or consolidation.
