8 **2011 Highway Department Employees Labor Agreement**

9  
10 **WHEREAS**, Washington County Code provides for County Board approval as a  
11 prerequisite to a voluntary binding agreement between Washington County and any employee  
12 labor group; and

13  
14 **WHEREAS**, a tentative labor agreement has been reached between Teamsters “General”  
15 Local Union No. 200 representing certain Highway Department employees and the Washington  
16 County Negotiating Committee for the period of July 1, 2011 to December 31, 2011, the original  
17 being on file and available for review with the Human Resources Department; and

19 **WHEREAS**, said tentative agreement has been ratified by the members of the employee  
20 bargaining unit and has also been ratified by the Administrative Services Committee of the  
21 Washington County Board; and

23 **WHEREAS**, the following issues summarize the major changes from the previous labor  
24 agreement:

- 25  
26 1. A six (6) month agreement that will be in effect from July 1, 2011 through  
27 December 31, 2011.

29 2. Wages – Effective July 1, 2011, employees will receive a 0% wage increase.

31 3. Remove all provisions that are prohibited subjects of bargaining.

33 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of  
34 Supervisors that said labor agreement between Washington County and Teamsters “General”  
35 Local Union No. 200, is hereby ratified, the original being on file in the County Human  
36 Resources Department.
