13 *as follows:*

15 **SECTION 1.** Section 7.02 of the Code is amended to read:

23 (19)(AM 13-12) The position is authorized on a limited-term basis for the period of ~~October 1,~~  
24 August 13, 2013 through June 30, 2015 and only while Patient Protection and  
25 Affordability Care Act (PPACA) federal and state funds meet the full cost of the position.  
26 No County levy shall be used to fund the position. Flexibility is given to allow the full-  
27 time position to be filled as two part-time positions.

32 **SECTION 2.** The list of pay grades established in Section 7.03(1)(a) shall be adjusted to  
33 incorporate the changes proposed in this ordinance.

35 **SECTION 3. EFFECTIVE DATE.** This ordinance shall become effective upon  
36 passage by the Board of Supervisors and publication as provided by law.
