### 2013 ORDINANCE 15

AN ORDINANCE to amend Section 7.03 relating to: Washington County Classification and Compensation Plan.

*The people of the County of Washington, represented in the Board of Supervisors, do ordain as follows:*

**SECTION 1.** Section 7.03(4) of the code is amended to read:

**7.03 WASHINGTON COUNTY CLASSIFICATION AND COMPENSATION PLAN.** (4)(AM 13-15) **Elected Department Heads.** (a) Pursuant to §§59.13 and 59.22, Wis. Stats., the County Board shall establish the salaries of certain elected department heads before the earliest time for filing nomination papers for such elective offices. The annual salaries set forth herein shall constitute "total annual compensation" as that phrase is used in §59.22(1), Wis. Stats. Elected department head's salaries shall remain in effect unless duly changed by the County Board.
