5 **2013 ORDINANCE 20**

6 AN ORDINANCE to amend Section 4.47 relating to: Child Support Agency – Non-IVD Fees.

8 *The people of the County of Washington, represented in the Board of Supervisors, do ordain*
9 *as follows:*

10 **SECTION 1.** Sections 4.47(1), (2) and (3) of the code are amended to read:

11 **4.47 CHILD SUPPORT AGENCY – NON-IVD FEES.** (1)(AM 13-20) Account
12 Reconciliation. Upon written request by a party to a case, the Agency will perform an account
13 reconciliation for a fee of ~~\$35~~ \$40 per request, which shall be paid prior to performance of
14 services.

17 (2)(AM 13-20) Income Withholding Order Entry. Upon the written request of a party to
18 a case, the Agency will draft and send an Income Withholding Order upon the establishment of a
19 support order, in the event of a new employer or unemployment claim, or a modification of an
20 order (including adding an arrearage payment) for a fee of ~~\$35~~ \$40, which shall be paid prior to
21 the performance of services.

24 (3)(AM 13-20) Reconciliation of Percentage Expressed Orders. Upon the written request
25 by a party to a case, the Agency will reconcile an account history with a percentage expressed or-
26 der to ensure that the amount of support paid to the date of the request and any arrearage are ac-
27 curate for a fee of ~~\$35~~ \$40 per request, which shall be paid prior to the performance of services.

30 **SECTION 2. EFFECTIVE DATE.** This ordinance shall become effective on January
31 1, 2014, upon passage by the Board of Supervisors and publication as provided by law.

33 **SECTION 3. SUMMARY.** Ordinance amending the fees charged by the Child Support
34 Agency for certain Non-IVD matters.
