8 AN ORDINANCE to amend Sections 7.02 and 7.03 relating to: Washington County Staffing
9 Plan - Human Services Department; and Washington County Classification and
10 Compensation Plan.

12 *The people of the County of Washington, represented in the Board of Supervisors, do ordain*
13 *as follows:*

15 **SECTION 1.** Section 7.02 of the Code is amended to read:

16 **7.02 WASHINGTON COUNTY STAFFING PLAN.** (AM 13-7)

26 (11) Employees hired in the position of Economic Support Specialist beginning January 1,
27 2012 to February 28, 2014 shall be placed in Grade 5, Step 1 for the duration.
28 Commencing March 1, 2014, the position(s) may merge with Economic Support
29 Specialist positions at Grade 6, Step 1.

30
31 (19)(CR 13-7) The position is authorized on a limited-term basis for the period of October 1,
32 2013 through June 30, 2015 and only while Patient Protection and Affordability Care Act
33 (PPACA) federal and state funds meet the full cost of the position. No County levy shall
34 be used to fund the position. Flexibility is given to allow the full-time position to be filled
35 as two part-time positions.

37 **SECTION 2.** The list of pay grades established in Section 7.03(1)(a) shall be adjusted to
38 incorporate the changes proposed in this ordinance.

40 **SECTION 3. EFFECTIVE DATE.** This ordinance shall become effective upon
41 passage by the Board of Supervisors and publication as provided by law.

43 **SECTION 4. SUMMARY.** Ordinance amending staffing plan for Human Services
44 Department adding 5 new positions.
