8 **Transfer from the General Fund – Deputy Sheriffs Contract - Back Pay**

10 **WHEREAS**, the Washington County Deputy Sheriffs’ Association representing certain
11 employees in the Washington County Sheriff’s Department and the Washington County
12 Negotiating Committee were unable to reach an agreement regarding wages for the period of
13 January 1, 2012 through December 31, 2013, and the matter was submitted to arbitration; and

14
15 **WHEREAS**, an arbitration decision was issued on July 19, 2013, accepting the
16 Washington County Deputy Sheriffs Association’s final offer, which included a 2.0% across the
17 board wage increase for 2012, status quo for WRS contributions and a one (1) year contract
18 duration beginning January 1, 2012; and

20 **WHEREAS**, the 2012 Collective Bargaining Agreement resulting from the arbitration
21 award remains in effect until an agreement is reached or a resolution is accomplished for 2013;
22 and

24 **WHEREAS**, the calculation for Deputy Sheriffs’ back pay has been completed and the
25 amounts are as follows: \$87,680 for 2012 and \$89,282 for 2013, for a total amount of \$176,962
26 in back pay; and

28 **WHEREAS**, the Sheriff’s Department 2013 Budget did not include Deputy Sheriffs’
29 back pay for 2012 or 2013; and

30
31 **WHEREAS**, there are sufficient funds in the General Fund to provide for the 2012 and
32 2013 back pay amounts;

34 **NOW, THEREFORE, BE IT RESOLVED** by the Washington County Board of
35 Supervisors that an amount of \$176,962 is hereby transferred from the General Fund to an
36 appropriate account in the Sheriff’s Department 2013 budget to fund Deputy Sheriffs’ back pay
37 for 2012 and 2013.
