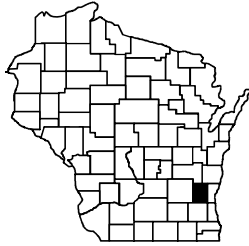

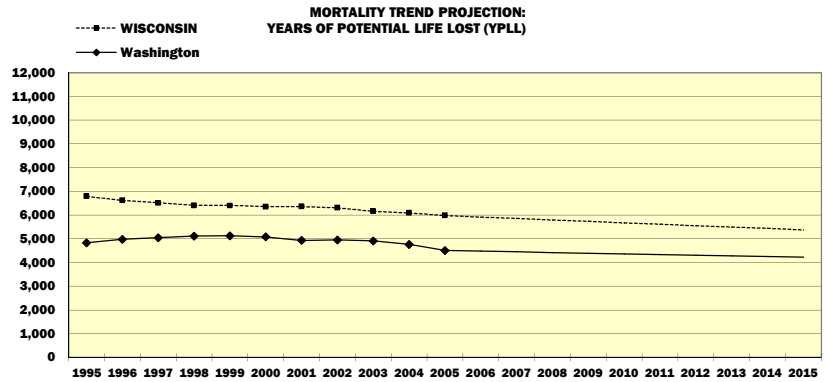
**LOCAL HEALTH AT A GLANCE:**
