

# 2019 National Conservation Poster Contest

# **Eligibility**

The National Conservation Poster Contest is open to kindergarten through twelfth (K-12) grade students. **Artwork entered into the national competition must have been judged in a local and/or area conservation department sponsored poster contest as well as a state conservation association contest.** Posters not sent by authorized state poster group will not be considered for judging.

There will be judging at the national level for all categories. To be eligible for national contest your state must have a state sponsor of the contest. The contest begins at your local county level.

#### **2019 Contest Theme**

The National Poster Contest theme is: Life in the Soil: DIG DEEPER

Poster Categories by Grade: K-1, 2-3, 4-6, 7-9, 10-12

The contest is open to all public, private and home schooled students.

### **Contest Rules**

The contest rules were created so as not to limit or revise the current rules of local and state conservation poster contests:

- Any media may be used- paint, crayon, colored pencil, charcoal, stickers, paper or other materials on regular posters.
- **♣** Poster size must be: 14" x 22".
- Posters should be packaged so they remain flat when sent for judging.
- ♣ All posters must be created by an individual student rather than a team of students.
- The 2019 stewardship title: Life in the Soil: DIG DEEPER must be on your poster.

  This is the only title eligible for the poster contest.
- ♣ Each entry must have signed entry form\* to be eligible for judging.
- → Although younger students will most likely receive help in planning from parents and teachers, NACD encourages each student to do as much as possible by him/herself. Entries completed by students in their handwriting and coloring will score better than those designed, drawn and colored with adult assistance.
- **Posters must first be judged at the local, area and state levels.** Each entry to the state contest must have been judged at each conservation department's and/or area contest prior to the state evaluation/contest.
- ♣ Individual posters cannot be sent for national judging by individuals. They must follow their state's contest rules and deadlines.

<sup>\*</sup>Each poster for the conservation contest must have the entry form <u>filled out and signed</u> by a parent or guardian.

## **Poster Evaluations**

Contest entries are reviewed by judges and evaluated on the following criteria:

- **Let Conservation Message/Correct Theme** (50%)
- **♣ Visual Effectiveness** (30%)
- **4** Originality (10%)
- **Universal Appeal** (10%)

## 2019 National Prize Money

The winning posters will be featured at the NACD Annual Meeting. Each state conservation association, auxiliary or agency contact will receive notification of the judging results and a news release announcing the winners. Posters not receiving national awards will be returned to the state contact in a timely manner following judging.
