26 A roll call vote was taken for Mr. Miller as Vice-Chairperson. Voting Aye: Mr. Ewert, Mr. Heidtke, Mr.
27 Miller, Mr. Schulz and Mr. Stern. Voting No: Mr. Bassill and Mr. Sorce. Mr. Miller received a majority
28 of the votes that were cast and Chairperson Stern declared him duly elected as Vice-Chairperson.

30 Mr. Heidtke announced his candidacy for Secretary. Moved by Mr. Miller, seconded by Mr. Ewert to
31 close nominations and cast a unanimous ballot for Mr. Heidtke as Secretary. Motion carried.

45 Mr. Odekirk introduced himself and presented an update on the Conservation Stewardship Program
46 (CSP) and Environmental Quality Incentive Program (EQIP) contracts and Organic Signup.

48 **LAND & WATER RESOURCE MANAGEMENT PLAN REVISION UPDATE**

49 Mr. Schmidt reported a final draft plan will be sent to the Committee a week prior to the public hearing.
50 The public hearing was tentatively set for June 29, 2010, at 7:00 p.m.

1 **2010 CLEAN SWEEP COLLECTIONS UPDATE**

2 Mr. Schmidt presented a summary of the April 17, 2010, Clean Sweep Collection. There were 138
3 hotline pre-registrations and 111 paid participants, including three walk-ins. Of these, 5 were agricultural
4 participants and 106 were residential participants. Collection totals included 450 lbs. of agricultural
5 bulked solvent flammables, 750 lbs. of agricultural lab pack quantity waste (aerosols, pesticides,
6 corrosives, etc), 3,150 lbs. of household bulked solvent flammables, 4,473 lbs. of household lab pack
7 quantity waste (aerosols, pesticides, corrosives, etc.), and 6,300 lbs. of electronic goods waste. The drug
8 collection had 214 participants and collected a total of 836 lbs. of waste.

10 **2010 NATIVE TREE & PRAIRIE SEED SALE UPDATE**

11 Mr. Schmidt reported the 2010 Tree and Prairie Seed program distribution was held on April 29 and 30,
12 2010, at Washington County Fair Park. Over 500 residents participated in the program.

24 Robert and Mary Ann Fellenz, Section 18, Town of Farmington for an underground outlet, in the amount
