**CONSIDER 2005 ORDINANCE 30 - COUNTY SALES AND USE TAX - (4.28)**

Chairperson Miller explained the reasons for this meeting. Finance Committee, at their February 1, 2006, meeting, added some language to Ordinance 30 that had not been reviewed by the Executive Committee. In looking at the state statutes, the county sales and use tax can only be used for reducing county proeprty tax and specific programs cannot be named in the ordinance. Chairperson Miller presented 2005 Ordinance 30 Substitute #1, which has a general reference to the Capital Improvement Program and lists future capial improvement programs, including a purchase of development rights initiative, in the fiscal notes of the ordinance.

For Executive Committee, moved by Mr. Tuchscherer, seconded by Mr. Spindler to forward 2005 Ordinance 30 Substitute #1 - County Sales and Use Tax - (4.28) to the County Board for approval. Motion carried. For Finance Committee, moved by Mr. Roskopf, seconded by Mr. Gonnering to forward 2005 Ordinance 30 Substitute # 1 - County Sales and Use Tax - (4.28) to the County Board for approval. Motion carried.

For Executive Committee, moved by Mr. Spindler, seconded by Mr. Tuchscherer to amend 2005 Ordinance 30 Substitute #1 - County Sales and Use Tax - (4.28) to include a review provision that the Chairperson is directed to place for consideration, the imposition of County Sales and Use Taxes on the agenda of the County Board during the calendar year 2011 at or before the July, 2011 meeting of the County Board of Supervisors. Motion carried. For Finance Committee, moved by Mr. Gonnering, seconded by Ms. Russell to approve the amendment to 2005 Ordinance 30 Substitute #1 - County Sales and Use Tax - (4.28) to include a review provision that the Chairperson is directed to place for consideration, the imposition of County Sales and Use Taxes on the agenda of the County Board during the calendar year 2011 at or before the July, 2011 meeting of the County Board of Supervisors. Motion carried.
