

Minutes of the  
HOME Board Meeting  
October 21, 2010

- I. The meeting was called to order by the Chair with a quorum of the Board present at 9:06 a.m.
- II. The Chair led the Pledge of Allegiance.
- III. On a motion by Mark Baldwin and seconded by Joe Birbaum, the minutes of the September 21, 2010 meeting were approved with Ron Buchanan abstaining.
- IV. No Public comments were heard. Staff indicated that the Wisconsin Partnership would be holding its 25<sup>th</sup> anniversary with two lunches, November 3<sup>rd</sup> in Milwaukee and November 16<sup>th</sup> in Madison.  
  
The Washington County Habitat for Humanity will also be holding its annual fund raiser on November 6, 2010 as reported by Mark Baldwin.
- V. The Wisconsin Partnership reviewed the Fund Balance Report and gave a summary of the new RESPA lending requirements which may impact the HOME program. A further explanation of the RESPA impact will be provided at the November meeting.
- VI. Staff reported an increase in the number of foreclosure filings to 17. Although not all foreclosure filings reach foreclosure, the County Corporation Counsel does file for loan repayments if any occur. Current foreclosures appear to be a result of economic conditions (household unemployment) rather than bad loans previously recorded.
- VII. Ms. Bernie Juno and Mr. James Tarantino provided a copy of the redesigned Summit Avenue development site and indicated that they were discussing financing with two lenders. Financing may be contingent upon approval of a letter of Commitment for site based vouchers from the Waukesha Housing Authority which will consider approval of site based vouchers at its meeting the week of October 25, 2010.

VIII. The Board continued its review of “HOME Funds Framework for Development Funds and incorporated changes discussed during the review”. The consultants CPDA represented by Bob Berlan and Marcia Bergeson will return in November to continue the review of the draft framework.

IX. On a motion by Joe Birbaum and seconded by Ron Buchanan, the meeting adjourned at 10:56
