20 **2008 CLEAN SWEEP SUMMARY**

22 Ms. Hoffmann presented a report of the Washington County Hazardous Waste Collection-Clean Sweep  
23 held on September 26, and 27, 2008. Twenty-five farmers and 12 small businesses participated on Friday  
24 and 597 households participated on Saturday.

26 **FUTURE CLEAN SWEEP ALTERNATIVES**

27 *Appearance: John Mueller & Joe Bauman, Veolia Environmental Services*

28 Mr. Bauman and Mr. Mueller discussed the household hazardous waste collection programs held in  
29 Waukesha and Milwaukee Counties and presented options for future clean sweeps in Washington County.  
30 Mr. Mueller recommended taking up this issue in May when the Committee could decide how to proceed  
31 for the 2010 grant cycle and budget. Dr. Hapner will bring back viable alternatives and costs at the next  
32 meeting.

34 **2009 MULTI-AGENCY LAND & WATER EDUCATION GRANT (MALWEG) UPDATE**

35 Dr. Hapner reported Washington County was awarded funds; however, across the board there was a 10%  
36 cut to the grant funding, so Washington County will receive \$13,500 of the \$15,000 that was applied for.

38 **2008 CONSERVATION POSTER CONTEST UPDATE**

39 Dr. Hapner reported all of Washington County first place winners advanced to the Southeast Area  
40 Conservation competition. Three of those four won at the state level and will compete at the national  
41 level in December.

44 Dr. Hapner presented a report on the Ozaukee/Washington Education Workshop held on October 21,
