**SCHUBERT CHEESE FACTORY LANDMARK**

Gary and Debbie Zurn appeared before the Commission in regard to their original application for landmark recognition. Mr. Zurn thanked the members for their support to save the cheese factory building, pending an appeal to a local governmental order to remove the building from the site. Mr. and Mrs. Zurn requested that the Commission reactivate the application and move forward to approve the cheese factory as a landmark. The Commission will review the application for a minimum of 60 days to give members time to check the refurbished property and review the application.

**THE LIVERY LANDMARK**

Greg and Gayle Dombrow, owners of The Livery landmark site, appeared before the Commission regarding discussion to alter a building on the site. The matter will be placed on the agenda March 6, 2006, for review and discussion.

**WINTER FARM LANDMARK SIGN**

New information, including a complete genealogy of the property, list of names of owners, documentation of number of years owned, copies of each deed or transfer, and other related information of land transfers, was forwarded to County Clerk Brenda Jaszewski regarding the request from Kim Hahn and Lauri Hassinger to change the landmark sign to list the Hassinger family's ownership of the Winter Farm property. It was moved by Ms. Blau, seconded by Ms. Densow that in view of new information and documentation of recorded deeds presented, the proposed text change for the Winter Farm landmark sign is approved, pending approval of the present-day owner, and that all costs to manufacture and install a new sign will be paid in full by the Hassinger family, and that the original landmark sign will be returned to Washington County, the owner of the sign. Motion was carried, 4 yeas and 2 nays.

**CELEBRATE FAMILIES RESOURCE FAIR**

Norbert Dettmann and Joan Baumgartner are prepared for the Celebrate Families Resource Fair February 12, 2006, 11-5 p.m. Participants in a scavenger hunt will stop at the display to work on a valentine project.
