JAMES KNEELAND HOUSE, City of West Bend, landmark dedication is scheduled August 22, 2007, at 2 p.m., pending installation of the plaque. Mr. Aaron Fuhreck informed the Commission that he sold the property to Mr. Mike Koebel who currently owns several old buildings in the City of West Bend, including The Washington House. Prior to purchasing the James Kneeland House, Mr. Koebel was fully aware that a Washington County landmark designation was applied for, and he intends to continue to maintain and preserve this property. Mr. Fuhreck was hired to manage the restaurant.

LANDMARK APPLICATION

Pam and Garret Terpstra, City of Hartford, **WESTPHAL MANSION INN**, are gathering historic documentation and tax records to complete their application. Ms. Merten and Ms. Wenzlaff will begin drafting the plaque narrative.

BUDGET

County Clerk Brenda Jaszewski informed members that the 2007 budget balance is \$5,490.00, which is sufficient to purchase 2-3 landmark plaques, reprint landmark driving tour brochures in 2007, and possibly reprint landmark coloring books in 2008.

LANDMARKS BOOTH AT FAIR
