WINTER FARM LANDMARK SIGN

Correspondence was received from Kim Hahn, Town of Polk, with documentation related to the sign on the Winter Farm Landmark. Ms. Hahn received information from Lauri Hassinger, Rochester, MN, that the property was owned by Johann and Elizabeth Hassinger prior to the Winter family ownership. Ms. Hassinger is the great-great-great-granddaughter of Johann Hassinger. Ms. Hahn requests that the Landmark Commission change the sign to reflect the new information. It was moved by Norbert Dettmann, seconded by Eileen Densow that the letter from Ms. Kim Hahn was discussed by members of the Commission, the Commission appreciates Ms. Kim Hahn's interest and research of the Winter Landmark, and the request to change the sign was considered; however, it is the policy of the commission that revising the sign could be accomplished but will be the cost of the person requesting a new sign. Motion carried. County Clerk Jaszewski would provide a quote upon request of Ms. Hahn.

MOLL HOMESTEAD

The application for considering the Moll Homestead for landmark recognition has not been received because of health issues of the owner, Marjorie Keding. The agenda item will be placed on hold indefinitely until the application is received at the Office of the County Clerk.
