Ms. Nass stated that all equipment on the towers is insured with a County 30 deductible of \$50,000. Towers are insured if we own them. No discount is given if we have ice shields. Mr. 31 Schrader asked that the minutes reflect that as Radio Administrator he recommends installing 14 ice shields. 32 33

Rather than install the old radios, Tyco has agree to give us those radios early to be installed in those vehicles and then reprogram later to be used in the new system. They will not charge for reprogramming and labor.
