20 **REVIEW AND REVISE TENTATIVE SUPERVISORY DISTRICT PLANS**

21 Mr. Damkot presented a tentative Supervisory District Plan draft plan #10a and gave a district summary
22 of the five areas of change in plan #10a.

23 The five areas of change are as follows:

- 24 1. Better population balance between districts 11 and 14
- 25 2. Better population balance between districts 1, 5, and 7
- 26 3. Removed Town of Polk block from District 16
- 27 4. Removed Town of Hartford blocks from District 22
- 28 5. Moved two census blocks from district 24 to district 23. The additional Richfield population
29 in District 23 will give Richfield the ability to create legal wards

31 Moved by Mr. Miller, seconded by Mr. Gundrum to approve the Supervisory District Plan #10a with the
32 changes that were presented today, and include the additional changes made to the City of West Bend.
33 Motion carried unanimously by roll call vote.
