Also 2 plots will be designated for the Germantown Senior Center for those seniors wanting small quantities of fresh produce. Last month the Board received a copy of the Healthy People Project success story about this garden.
 - c) February 12, 2013, Joni Whitehouse, Deputy Health Officer and Healthy People Project Co-Chair was the guest speaker for the West Bend Sunrise Rotary group and gave an overview of the Coalition's activities
 - d) The Washington County Injury Prevention Coalition long term goal of having individual communities sponsor "Every 15 Minute" events is progressing. This year Germantown High School is conducting their own event with minimal assistance from the Coalition and West Bend High Schools are taking the lead on the project with support and assistance from the Coalition. Kewaskum High School has confirmed participation for 2014 and Hartford High School is considering a 2014 program. The Coalition will be conducting before and after seat belt use surveys at UWWC and the West Bend High Schools during March, April and May. Educational handouts about distracted driving and seat belt use will be distributed.
